English District of The Lutheran Church—Missouri Synod Ministry Tent - Exhibitor Display Contract

This contract is entered into this day by and between The English District of The Lutheran Church—Missouri Synod (English District-LCMS) and exhibitor listed below (exhibitor) concerning exhibit space for the *English District Convention 2022*. English District-LCMS is an Illinois Nonprofit Corporation with its principal place of business at 33100 Freedom Road, Farmington, MI 48336.

General Convention Information

The Convention will be held from Monday, June 20 through Wednesday, June 22, 2022 at Concordia University, 4090 Geddes Road, Ann Arbor, Michigan. Exhibit space will be contracted for the days Monday, June 20 and Tuesday June 21, Additional convention information is available on the District's website at https://englishdistrict.org/events/57th-englishdistrict-convention.

IT IS AGREED:

- 1. **Exhibitor Display** Subject to the terms and conditions hereof, English District-LCMS hereby agrees to provide the exhibitor with space under the Ministry Tent Monday, June 20 and Tuesday, June 21. Said space will be 9 feet x 9 feet or 9 feet x 5 feet and supplied with two chairs and one covered table. The location of the space shall be assigned by the English District-LCMS. Other furnishings will have additional expenses (electricity, additional tables, chairs, etc.).
- 2. **Fees** Exhibitor display fee is \$375; electricity is available for an additional \$40. A discounted fee of \$175 will be offered to non-profit organizations that derive 75% or more of their income from gifting. Each representative from an organization must register and pay a \$25 registration fee. Conference meals are also available for a fee and will be served with delegates. Representatives already registered as voting/advisory delegates and/or guests do not need to pay a registration fee.
- 3. **Installation of Display** The exhibitor shall set up its display in its assigned space between the hours of 8:00 am and 11:00 am on Monday, June 20. In the event the exhibitor fails to install its display by 11:00 am on Monday, June 20, the English District-LCMS may, without notice to the exhibitor, terminate this contract without refund and reassign the contracted space. All decorative materials, flags, signs, equipment, and other such items installed by the exhibitor in its space shall comply with all ordinances, rules, and regulations relating to fire safety promulgated by the City of Ann Arbor, by Concordia University Ann Arbor, or other legal authority.
- 4. **Display Hours** The exhibitor agrees to have its booth staffed during **ALL** hours of operation. The Ministry Tent is scheduled to be open:

Monday, June 20 - 11:00 am to 6:00 pm

Tuesday, June 21 - 9:00 am to 6:00 pm

Ohio District Convention will begin Wednesday, June 22

- 5. **Assignment and Use by Others** The exhibitor shall not assign its rights herein nor permit any other person, firm, or corporation to use any portion of its assigned space without written consent from English District-LCMS.
- 6. **Food and Beverage Distributions; Sales of Items** Sodexo Food Service at Concordia University is the exclusive provider of food and beverages for the convention. Exhibitors may not sell food or beverages anywhere on Concordia University property. Exhibitors that offer non-food items for sale at the Convention must comply with all governmental regulations, including having a sales tax license on location.
- 7. **Exhibitor Responsibility** The exhibitor shall be solely responsible for safeguarding all property of the exhibitor in its space or at any time located elsewhere at the conference site and the exhibitor waives all claims against the City of Ann

Arbor, Concordia University Ann Arbor and the English District of The Lutheran Church—Missouri Synod, and holds all persons, firms, and corporations associated therewith harmless from any and all liability and expense arising out of or in connection with any claims, demand of cause or action resulting in whole or in part from the act of the exhibitor or its representatives or from the exhibitor's use and occupation of its space or acts thereto.

Exhibitor shall be liable for all damages to property and equipment (normal wear and tear excepted) and personal injury caused directly by and to the extent of the acts, errors, or omissions of exhibitor, its agents, and employees. Exhibitor will secure and provide insurance coverage for such liability.

- 8. **Failure to Provide Display Space** In the event the English District-LCMS fails to provide the exhibitor with space as herein required for any reason whatsoever, including without limitation fire, strike, cancellation of the conference, or cancellation of any underlying agreement, the English District-LCMS shall promptly refund any fees paid to the English District-LCMS and the same shall be accepted by the exhibitor as liquidated damages for all loss or damage suffered by the exhibitor from such failure.
- 9. **Special Restrictions** The English District-LCMS reserves the right to terminate this contract and/or prohibit the installation or operation of any display, any part thereof or any activity in connection therewith which the English District-LCMS, in its discretion, determines to be inconsistent with the character of the convention. The English District-LCMS further reserves the right to issue such rules and regulations concerning the operation of the exhibitor's display as it determines are necessary and appropriate and the exhibitor hereby agrees to abide thereby.
- 10. **Shipping** If you need to ship boxes, please address them to Concordia University and note "English District Convention 2022" on the boxes. Shipping address: Concordia University, English District Convention, 4090 Geddes Rd, Ann Arbor, MI 48105. Plan to be in the tent at 8:00 am on Monday to receive any boxes you've sent.
- 11. **Notices and Payment** All notices and payment to the English District-LCMS shall be sent to English District-LCMS, Exhibitor Registrations, 33100 Freedom Road, Farmington, MI 48336-4030 no later than April 30, 2022.
